 - i. Professional Development vs. In-service/Classroom resources clarification
 - ii. Tamara & Carla meet monthly to approve PD requests. This aligns with how most locals manage their pro-d funds. It allows us to discuss each request together in person & ensure applicants are eligible for the funds they are requesting (spreadsheet indicates who has accessed which funds/which year). - i. Policy review of NDTA Pro-D Policy
 - 1. Statement of intent, Pro-D funding, & the Pro-d committee directly from Section F, Article 20 (as per our District Policy).
 - a. Went over sections of our collective agreement that pertains to pro-d.
 - b. Went over changes to the policy. Most of the changes are to add clarity to the policy.
 - c. Change in policy to allow up to \$200 to be used for any credit courses (they may or may not lead to an additional degree, certificate, or special certification.
 - i. There was conversation both for and against this change.
 - ii. Talk about how many university courses are very good professional development, for example, the Indigenous language course put on through Selkirk.
 - iii. Concern about not allowing professional development funding be used for the purpose increasing a person's pay, or becoming certified in specific areas that will allow them to consult outside their school district position.
 - 2. District Professional Development Committee Carla (or Karen), Ben, Gail, Tamara, + 2 PD chairs Creston side.
 - a. Please send any pro-d requests to Tamara and/or Carla and they will bring up with the committee.
 - 3. Role of the Pro-D rep important for the rep to keep the PLDPs that are submitted & that they are not mandatory for teachers every year. They may simply say that they will be engaging in the district pro-d.
- ii. To be taken to the Executive Meeting for approval on November 7.
- c. Pro-D Funding changes next year due to minimum provincial standard for pro-d funds negotiated by the last bargaining team.
- 5. Mentorship Program (Carla) pair up an experienced teacher with a teacher new to teaching/new assignment. Encourage people to consider joining in. Handbook (Caleb Morton) will be available on the NDTA website.
